Every module of STEFAN contains 3 steps:

- First step: a test called Competence Validation Tool. Participants have to answer the
 questions, and after they finish they receive feedback with their result. The aim is to
 measure the participant's knowledge in connection with the modules of the project.
- Second step: the module itself. Participants have to read them through individually. The time frame for the modules 1-3 is 5 days.
- Third step: test for self-assessment. Participants can check what they learned from the module. Instant feedback will be provided with the correct answers.

General information (app. 10 minutes)

- Ask the participants that if they find any mistake/problem in the material or face any difficulties on the platform make notes of it or print screen
- Emphasize their key role in the process their feedbacks and comments are essentials, ask them to be open and do not shame to share any kind of advice, suggestions or critics


